REBECCA'S TREATMENT TIMELINE



SAME-DAY CONSULT

Rebecca's Summus MD provides specialist referral The same day she spoke with her Summus MD, Rebecca received a curated list of in-network OBGYNs with same-week availability. She secured an appointment for that Thursday, avoiding the two-week wait she was originally given.



4 DAYS LATER

DIAGNOSIS

Rebecca is Diagnosed with DCIS

After connecting with the Summusrecommended breast surgeon, Rebecca undergoes a biopsy. Pathology confirms a diagnosis of ductal carcinoma in situ (DCIS). Her surgeon initiates further testing, including hormone receptor status and imaging to better understand the disease and begin planning treatment.



SURGERY RECOMMENDED

Rebecca is Recommended Surgery

Rebecca's breast surgeon recommended moving forward with surgery. She explained that if invasive cancer is found in the final pathology, chemotherapy or other treatments may be needed. Feeling overwhelmed, Rebecca reached back out to Summus for guidance and support.



NEXT DAY

Summus Provides Guidance on Next

The next day, Rebecca reconnected with her Summus MD to review her biopsy, images, testing results, and recommendation for surgery. The Summus MD recommended speaking with a specialist for an in-depth video consultation.



8 DAYS LATER

Rebecca Consults with the Director of Breast Oncology at Stanford

Eight days later, Summus arranged a consultation with leading doctor of the Breast Oncology Program at Stanford, who reviewed Rebecca's records and supported the plan for surgery. He addressed her questions about radiation, chemotherapy, and other treatments, and when each may be needed based on the post-surgical pathology report. Rebecca left the conversation feeling informed and reassured.



REBECCA'S ONGOING SUPPORT & TREATMENT



SURGERY

Rebecca Undergoes Surgery Rebecca proceeded with a lumpectomy and a sample was sent to pathology to determine if additional treatments would be needed.

Pathology revealed that her cancer was intermediate-grade, and her surgeon discussed the possibility of radiation as a next step to reduce the risk of local recurrence, referring her to a radiation oncologist and medical oncologist.



HESITANT ABOUT RADIATION

Rebecca Reconnects with Summus

Hesitant about radiation, Rebecca reconnected with the doctor from Stanford through Summus. He reviewed her pathology along with her concerns about radiation and encouraged her to discuss hormonal therapy options with her medical oncologist.



SHARED DECISION-MAKING

Rebecca Meets With Medical Oncologist Taking the Stanford doctor's recommendations, Rebecca met with the medical oncologist she was referred to. After reviewing her pathology - showing small DCIS with clear margins - the oncologist discussed both radiation and hormonal therapy. Given Rebecca's preferences and low-risk features, they agreed on starting hormonal therapy with close monitoring, allowing her to defer radiation at this time.



HOLISTIC SUPPORTRebecca Relied on

Rebecca Relied on Summus Support Throughout her treatment, Rebecca accessed additional Summus services, including:

- Lifestyle medicine consultations for nutrition guidance
- Mental health support to help her manage the emotional toll of treatment

AFTER TREATMENT

Rebecca Consults with Summus on Long-Term Plan After completing her treatment, Rebecca consulted her Summus MD to discuss long-term health planning. Together, they developed a personalized recovery and surveillance plan, including:

- A schedule for follow-up screenings
- Lifestyle adjustments to support recovery and reduce recurrence risk
- Genetic counseling to assess cancer risk for her young children
- Ongoing mental health support to navigate health anxiety
- Guidance from oncology social worker to help navigate work and family life post-treatment



6 MONTHS LATER
